- Save original VIN plate and/or Safety Certification Label that was removed from vehicle until new VIN plate and/or Safety Certification Label arrives.
- Use attached Affidavit to request a replacement VIN plate and/or Safety Certification Label.
- Information from original VIN plate and/or Safety Certification Label will be required to complete the Affidavit.
- Provide the completed Affidavit to your Fixed Operations Manager (FOM).

**!** Note: Ensure that a dealer representative has signed and dated the Affidavit before it is provided to the FOM.

- Replacement VIN plate and/or Safety Certification Label will be shipped from the factory to the FOM for delivery to the dealer.
